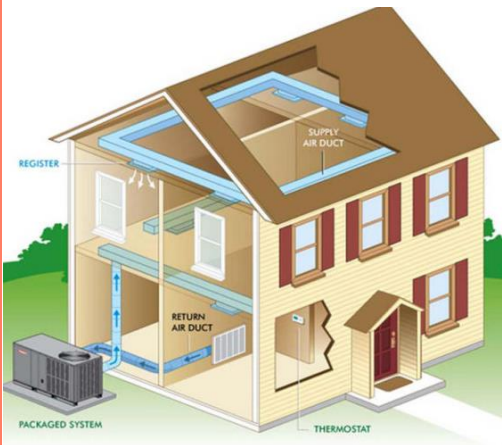


ELECTRIC HEAT RATE

5.7 cents/kWh

Electrical heat systems are eligible for the reduced electrical rate on all energy used by the heating system.

- ✓ The system will be sub-metered to determine usage.
- ✓ Comparing a 90% propane efficiency furnace to an electric air source heat pump – you would need to purchase propane for **.72/gallon**.
- ✓ Co-op furnishes a load management device at no cost to the member.

WATER HEATERS

Members replacing an existing or adding a **new lifetime-warranty** water heater may receive a \$6/gallon rebate.

Must be 50 gallons or larger.

LOANS

CCEC offers three types of loans

1. Air-source or Geothermal Heat Pumps
2. Irrigation System Auto Restart
3. Energy-Efficient Home Improvement
 - a) Caulking
 - b) Wall, floor, ceiling, duct, pipe, and water heater insulation
 - c) Storm or thermal windows and doors
 - d) Clock thermostats
 - e) Attic ventilation fans
 - f) Electric water heaters which reduce the consumption of electricity
 - g) Devices that reduce the maximum coincidental or non-coincidental demand on the electric system

Terms of the Loan

- Loans amounts not to exceed \$20,000 for Air-Source, Geothermal Heat Pumps, and Irrigation Auto Restart Loans.
- Loan amounts not to exceed \$10,000 for Energy Efficient Home Improvement Loans.
- 5% Interest annually on the unpaid balance. The maximum length of the loan is 84 months.
- All loans must be approved by the CCEC Board of Directors.

All units must be connected to a Load Management device to receive the rebate and/or monthly credit.
